RECRUITMENT NOTICE FOR APPOINTMENT OF ADJUNCT ASSISTANT PROFESSOR (AAP) (ON TEMPORARY BASIS)

Indian Institute of Information Technology, Pune (IIITP) is one of the 20 Indian Institutes of Information Technology established under Public-Private Partnership Scheme by Ministry of Education (MoE), Government of India. IIITP has been declared as an “Institution of National Importance” and at present the Institute is functioning under Department of Higher Education, Ministry of Education, Govt. of India

IIIT, Pune is offering Undergraduate and Postgraduate and PhD Programmes courses in Computer Science & Engineering (CSE) and Electronics & Communication Engineering (ECE) Humanities and Social Sciences (HSS), and Management. The Institute is located at satellite campus, **S No. 9/1/3, Ambegaon Budruk, Sinhagad Institute Raod, Pune - 411041.**

The development of state-of-the-art Permanent Campus of the Institute is being undertaken on sprawling 100 Acres of land.

The Institute is looking for a dedicated and committed Indian National to fill up the following post:

Note: The above posts of AAPs are to be filled purely on a temporary and contractual basis for a period of 11 (eleven) months, which may be extended based on performance. The last date for submission of applications is 3rd September 2024 by 17:00 IST.

1. The relevant details are as under:

- **Job Description:** Primarily Teaching along with Academic, Administrative, Student Activities and Research related functions.
- **Reporting To:** Dean / Head of the Department or as advised from time to time.
- Candidates who have completed defense for the PhD before closing date for the receipt of the Application Forms will have to attach the Certificate / Notification mentioning that Candidate is

declared eligible for award of PhD Degree.

- **Desirable Experience:** Minimum of one year will be preferred in Teaching / Research / Industry.
- **Desirable Requirement:** Candidate having PhD from CFTIs like IITs, NITs, IIITs, INIs etc will be preferred. The persons with higher qualifications & good academic record shall be given preference.
- **Emoluments:** Rs. 70,000/- per Month: PhD Holders (PhD Thesis submitted)
Rs. 60,000/- per Month: Non-PhD Holders

2. IIITP encourages its Faculty Members for active research, consultancy, and skill enhancement training for revenue generation. Candidates who are qualified and have such skills, capabilities resulting in revenue generation, institute brand development are most encouraged to apply.

3. **General Information & Instructions:**

- a) The Institute reserves the right to increase or decrease the number of posts to be filled as per the sole discretion of the Director, IIITP.
- b) The posts are on purely temporary basis and contractual basis for eleven (11) months, which may be extended based on performance.
- c) The Institute reserves the right to terminate the candidate any time with **One Month Notice** without assigning any reason thereof.
- d) The Institute reserves the right to reject any/all application(s) and/or cancel the advertisement in whole or in part without citing any reason at any stage of processing.
- e) No TA/DA and/or Lodging/Boarding will be paid for attending the Written Test/Interview. No accommodation shall be provided.
- f) The applications are to be filled and sent to the prescribed email within prescribed time limit, Incomplete application will be rejected.
- g) Applicants are not required to send a hard copy of the application to the Institute. However, the applicants are advised to email a copy of the application to aap_recruitments@iiitp.ac.in.
- h) Candidates are advised to fill in the Prescribed Application Form as per **Annexure-A** within the stipulated time. Application(s) received after the last date will not be entertained for the selection process.
- i) Further, the Candidate will have to bring the original and one set of self-attested photocopies of documents at the time of interview, the date of which shall be intimated to the eligible candidate in due course. At the time of verification of documents, if documents are not as per Institute's criteria or originals are not presented then candidate will not be allowed to attend Interview / selection shall be cancelled. Hiding information or submitting false information will lead to cancellation of candidature at any stage of recruitment.
- j) Candidates are advised to fill in the information carefully on the application form. Institute will neither be responsible for any wrong information furnished by the candidate(s) nor accept any subsequent requests for making any corrections. The candidate(s) shall be solely responsible for the information filled in on the online application form. No change/deviation, whatsoever, will be entertained.
- k) The candidates are required to have at least one **working email (Gmail only) and Mobile Number** which will be used during the entire selection process for communication, if required.
- l) Any modification/correction/addition etc. if any, related to the Advertisement and/or related to the recruitment process will be uploaded on the Institute web site only. No other means of communication will be used for the same. Therefore, the candidates are advised to periodically visit the Institute website for updates, if any.
- m) The date for determining eligibility of candidates in every respect shall be prescribed as the last date.
- n) The Institute reserves the right to set higher norms than minimum while short listing considering the specific requirements of the Institute. The decision of the Institute related to all matters pertaining to the recruitment

shall be final and binding on the applicants. Fulfillment of qualifications per-se does not entitle a candidate to be called for the selection process.

- o) Only the short-listed candidates shall be informed about the mode, date, and other relevant details for the interview / test. No correspondence regarding reasons for not shortlisting the candidate should be entertained. The decision of the Screening / Selection Committee shall be final in all respects.
- p) The Institute shall communicate the relevant details pertaining to the joining only to the selected candidate(s) directly through email. No communication shall be done with / entertained to / from the candidate(s) who have not been selected.
- q) In case of any inadvertent mistake in the process of selection detected at any stage even after the issue of Appointment Letter, the Institute reserves the right to modify/withdraw/cancel any communication made to the candidates.
- r) The Institute shall verify the antecedents and documents submitted by a candidate at the time of appointment or at any time during the tenure of the service. In case, it is detected that the documents submitted by the candidates are fake or the candidate has a clandestine antecedents/background and has suppressed the said information, then his/her services shall be terminated, and legal action may be initiated against such candidates/employees at their cost of consequence.
- s) The Institute reserves the right to assign / transfer the selected candidate to any section / department within the Institute.
- t) In case of any dispute regarding Recruitment Process, decision of the Director, IIITP shall be final. In case of any Legal Dispute regarding the Recruitment Process, the place of jurisdiction shall be Pune, Maharashtra (India) only.
- u) Canvassing in any form or any attempt to influence the Recruitment Process whatsoever will lead to disqualification of candidature. No interim enquiries will be entertained.
