Applications are invited from the eligible candidate for the post of Junior Research Fellow, Technical Assistant and Data Entry Operator purely on a temporary and contractual basis in an ad-hoc project entitled “Strengthening of Research for sustainable yield and value addition in Soybean”, at State Level Biotechnology Centre, MPKV, Rahuri.

The applications will be scrutinized for the eligibility. If a number of applications are more, mere fulfillment of essential qualifications will not be eligible for interview and only short-listed candidates based on merit and desirable qualifications will be called for the interview. No additional documents other than those submitted with the application will be accepted separately either before the last date, after the last date; or at the time of interview. The date of interview will be communicated to eligible candidates separately by email and text message on mobile.

**The said fellowship is awarded on the following terms and conditions**

1. The above assignment of Junior Research Fellow, Technical Assistant and Data Entry Operator **is purely on temporary and contractual basis** for a period of 6 months from the date of joining or closure of the said project whichever is earlier.
2. The candidate shall be eligible to draw fixed salary (As mentioned in above table) and shall not be eligible to draw dearness allowance and any other allowances except sanctioned by the Government of Maharashtra.
3. The said assignment shall be governed by the terms and conditions prescribed by the University vide U. R. referred to above at Sr. No. 3 and as amended from time to time notifications.
4. The candidate shall have to execute a bond on court for stamp worth Rs. 100/- giving an undertaking that he has accepted the post and agree with terms/conditions as prescribed by ICAR. He should not leave the project during and/or in the middle of the tenure. Further, however, if he intends to do so he/she shall have to give one month's notice in writing in advance or remit the amount of one month's fellowship.
5. Concealing of facts or canvassing in any form shall lead to disqualification of the candidature or termination even after appointment.
6. While leaving the fellowship, he/she has to hand over the complete charge to a person nominated by the Officer Incharge / Co-Principal Investigator and obtain No Objection Certificate from Principal Investigator.
7. He/she shall be a full time worker for the entire term and he/she will not be allowed to accept any other appointment / assignment during the period of award of fellowship.
8. The candidates already employed should apply through proper channel/ submit NOC of employer.
9. The candidate shall have to perform all duties / responsibilities that will be assigned to him by the Officer Incharge / Co-Principal Investigators per requirement of Scheme / Project.
10. As this is not a permanent post created in the project, the services are engaged purely on temporary basis during the tenure of the project as above. After expiry of the project he shall not have any legal right of claiming any benefit of the permanency on his or any of the similar post in the services of the Mahatma Phule Krishi Vidyapeeth, Rahuri.
11. The notification does not mean that the post of Junior Research Fellow, Technical Assistant and Data Entry Operator will necessarily be filled in. The discriminatory powers will rest with the selection committee constituted for the purpose.
12. The eligible candidates will be interviewed by the selection committee. The applicants will have to appear for interview on the prescribed date and time at their own cost and no TA/DA and accommodation will be provided for appearing in the interview.



13. The Director / Officer Incharge reserves the rights to cancel / postpone the interview without assigning any reason thereof.
14. He will be discontinued at any time if his work not found satisfactory.
15. On the acceptance of the said assignment on the terms and conditions as above, the candidate should join the said assignment within **15 days** from the date of receipt of order failing in which the said order will automatically stands cancelled.
